About the Contributors

Vito Tanzi was Director, Fiscal Affairs Department, and Chief, Tax Policy Division, at the International Monetary Fund (IMF) from 1975-2000. In that role, he advised the governments of many countries on fiscal issues and on tax reforms while supervising several highly trained fiscal economists from various countries. After the IMF, he served in the Italian Government as Undersecretary for Economy and Finance at the ministerial level. Subsequently, he spent some years as a visiting scholar at the Inter-American Development Bank in Washington DC. From 1990-94 he was the president of the International Institute of Public Finance (IIPF) He is now the honorary president of IPPF. He was awarded several honorary degrees from universities in Italy, Argentina, and Portugal.

During 1967-75, he was Professor of Economics (Department Chair, 1970-73), American University, Washington DC, and taught Public Finance and Income Theory at the graduate level. He visited the universities of Munich, Bocconi, Torino, Rome, and others. During 1959-1961 he worked for the Joint Economic Committee of the US Congress. From 1965-67 he was a senior economist in the Joint Tax Program of the Organization of American States (OAS) in Washington. He has been a consultant to the UN, European Commission, European Central Bank, World Bank, Organization of American States, and Inter-American Development Bank. He continues to participate and lecture at many international conferences.

In recent years, he has dedicated himself to the economic role of government in market economies, and the role that complexity plays in government's activities. He is also a prolific author, published by Cambridge University Press (2022, 2018, 2011), Elgar (2018), Oxford University Press (2020), and others.

He has contributed to the economics of corruption, tax evasion, money laundering, the underground economy, and the impact of inflation on tax systems. *American Economic Review*, *Journal of Political Economy*, and *Economic Journal*, and several other refereed journals have published his research papers. The "Tanzi effect"—the impact of inflation on the real value of government revenue—was named after him.

He is an MA (1963) and a Ph.D. (1967) from Harvard University and a BA with special honours (1959) from George Washington University where he has also done his first MA in 1961.



Dr. Parthasarathi Shome is Chairman, International Tax Research and Analysis Foundation (ITRAF), Bengaluru, India, and Visiting Senior Fellow, London School of Economics. He received Brazil's highest civilian honour, Commander of the Order of the Southern Cross, for his contributions to Brazilian fiscal reform. He was Adviser (Minister of State) to the Indian Finance Minister and chaired the Tax Administration Reform Commission (TARC). Earlier, he was Chief Economist, UK Revenue and Customs; Chief of Tax Policy, IMF; and Professor, American University, Washington DC. He chaired India's Ninth and Tenth Five Year Plan Task Forces on tax policy and administration. He was Director of the National Institute of Public Finance and Policy (NIPFP) and the International Council for Research on International Economic Relations (ICRIER), New Delhi, India. His publications in peer-reviewed journals include *IMF Staff Papers*, *National Tax Journal* (US), *Bulletin for International Taxation* (Netherlands), *Oxford Economic Papers* (UK), *Oxford Review of Economic Policy* (UK), *Public Finance* (Europe), *Public Finance Quarterly* (US), and several other international and national journals. He has edited and published many books with renowned publishers such as Business Standard Publishers, Cambridge University Press, CenTax, International Monetary Fund, Lexis Nexis, OakBridge, Orient Blackswan, Oxford University Press, Routledge, Springer, and Wolters Kluwer.
